

SWIMMING POOL RULES

1. HOURS OF OPERATION ARE 6:00 A.M. TO 9 P.M.
2. **NO LIFEGUARD ON DUTY AT ANY TIME.**
3. ONE (1) MAGNETIC KEY HAS BEEN ISSUED TO EACH UNIT. THE GATE IS SELF-LOCKING AND OPERATES ONLY WITH THE MAGNETIC KEY AND ONLY DURING POOL HOURS OF OPERATION. A REPLACEMENT KEY WILL COST \$115.00. **KEY MUST BE USED FOR ENTERING AND EXITING THE POOL AREA.**
4. PROOF OF RESIDENCY/OWNERSHIP MAY BE REQUIRED.
5. CHILDREN FIFTEEN (15) YEARS OF AGE AND YOUNGER ARE NOT PERMITTED IN THE POOL AREA WITHOUT AN ADULT. THIS RULE IS BASED UPON RESONABLE SAFETY CONCERNS RELATED TO THE POSSIBILITY OF INJURY OR DROWNING INVOLVING CHILDREN THAT ARE NOT SUPERVISED IN THE POOL AREA. PROOF OF AGE WILL BE REQUIRED.
6. RESIDENTS MAY HAVE TWO (2) GUEST PER HOUSEHOLD. **RESIDENTS MUST BE PRESENT DURING GUEST(S) USE** UNLESS THE GUEST IS AN IMMEDIATE (ADULT) FAMILY MEMBER. RESIDENTS WILL BE HELD RESPONSIBLE FOR ACTIONS AND DAMAGES CAUSED BY THEIR GUEST(S).

7. PETS OR ANIMALS ARE NOT PERMITTED IN THE POOL AREA EXCEPT FOR HELPER DOGS. THIS IS A ST. LOUIS COUNTY ORDINANCE.
8. ALCOHOLIC BEVERAGES ARE NOT PERMITTED IN THE POOL AREA.
9. **NO** GLASS IS PERMITTED IN THE POOL AREA.
10. RADIOS/TAPE/CD PLAYERS/ECT, MAY BE USED AT LOW VOLUME. IF REQUESTED BY ANOTHER RESIDENT, THESE ITEMS MUST BE USED WITH EARPHONES.
11. AIR MATTRESS, SWIM RIMS, MASK AND ALL OTHER ACCESSORIES SHALL BE LIMITED TO TIMES WHEN THE USE OF THESE AND OTHER "POOL ITEMS" WILL NOT INTERFERE WITH OTHER SWIMMERS USE OF THE POOL AND POOL AREA.
12. NO ROUGH PLAY, RUNNING OR FOUL LANGUAGE.
13. **ONLY** SWIMSUITS AND TRUNKS IN POOL.
14. ANYONE CAUSING DAMAGE TO PROPERTY SHALL BE HELD PERSONALLY RESPONSIBLE.
15. ALL ITEMS LEFT AT THE POOL WILL BE THROWN OUT.
